There are two ways to use Form 9465. The first is if you cannot pay a current tax, which is the tax for the return you are about to file. Rather than failing to file the return (a mistake made by too many each year), file the tax return on time--thus avoiding the failure to file penalty--but include Form 9465 as an attachment to the return.
